FY 2025/26 Healthy Soils Cover Crop Program Guidelines

- The healthy soils cover crop program is conceived to be a **multi-year program** with an end goal of establishing a multi-species perennial and drought tolerant groundcover.
- For consideration, applicants to this program must submit a signed FY 2025/26 Taos SWCD Healthy Soils Cover Crop Program application.
- Approved applicants will be assigned “Cooperator status.” Prior to seed distribution, cooperators will be required to meet Taos SWCD staff in their field(s) for a rapid soil health assessment and in-field orientation to the Taos SWCD healthy soils program.
- Once approval for seeding is granted, a **\$25/acre cost-share payment will be required from the Cooperator** to participate in the Program. This cost share helps purchase additional seed not covered by the grant.
- Upon receipt of the deposit, Taos SWCD will provide the Cooperator with high-quality cover crop (mixing annual and perennial seed) at an NRCS-recommended rate per approved acre. Seed is selected for suitability to Taos County’s climate, planting season, and whether the site has access to supplemental irrigation.
- Once the Cooperator has provided documentation (photo/video) of seed being planted prior to the monsoon deadline of 8/15/25 or the fall deadline of 10/31/25, Taos SWCD will reimburse the cooperator at a rate of \$130/acre for planting. Seed must be drilled or broadcast and covered with soil with a tractor-based implement to be eligible for reimbursement. Cooperators with sufficient livestock density are eligible to broadcast seed and use animal hoof action to incorporate seed into the soil. **Cooperators broadcasting seed without ensuring sufficient seed to soil contact will not be eligible for planting payments.**
- Individual projects will vary in size and will not exceed four acres per Cooperator. The Taos SWCD FY 2025/26 Healthy Soils Cover Crop Program is limited to an overall total of 280 acres within Taos County. Cooperators with acreages below 1 acre will be reimbursed at the discretion of Taos SWCD.

IMPORTANT: If a Cooperator fails to provide acceptable documentation that the seed was planted prior to the respective deadline, Taos SWCD will not reimburse for planting.
