



## **Well Water Quality Testing Program**

### **What is the Well Water Quality Program?**

One of the goals of the Taos Soil and Water Conservation District is to educate *private* well owners about the importance of water quality and how it impacts both health and overall quality of life. Through this program, we aim to address water quality concerns related to nonpoint source groundwater contamination. Our approach combines awareness with action, empowering homeowners to take proactive steps in protecting their water sources. We wish to support homeowners by offering cost-sharing opportunities for water testing for **Taos County residents located outside the Town of Taos.** Depending on the type of test you choose, we can help reduce the cost, making it easier for you to better understand and protect your water quality.

### **Why test my water?**

If you rely on a private well for your drinking water, it's important to know that your water is not monitored by city, state, or federal agencies. As a well owner, you are solely responsible for ensuring the safety and quality of your water. Water quality issues can sometimes occur without any noticeable signs—such as changes in taste, color, or smell. That's why routine water testing is essential, even when everything seems normal.

### **When should I get my water tested and how often?**

Private well owners should test their water for bacteria and nitrate annually. In addition, drinking water should be tested if:

- You notice a change in your water quality (change in water taste, color, or smell).
- There are changes in the water availability (Water Table dropped).
- People drinking the water suffer from an illness that may be waterborne.
- After a natural disaster such as wildfire or flood.
- You replace or repair any part of your well system.
- You are having problems with your septic tank.
- You identify a major water leak.
- When children, babies, or a pregnant person will be living in the home.
- If your well has never been tested.

## **Identifying reasons to test your water**

According to the [EPA.gov](https://www.epa.gov/privatewells/protect-your-homes-water), the chart below lists common conditions or nearby activities that well owners should be aware of and the substance(s) that you should consider testing for to ensure your well is safe. Not all of the substances listed pose an immediate or long-term health problem, some impact quality of life only such as appearance, taste, and odor.

<b>Conditions or Nearby Activities:</b>	<b>Test for:</b>
Recurring gastro-intestinal illness	Coliform bacteria
Household plumbing or service lines that contain lead	pH, lead, copper
Radon in indoor air or region is radon rich	Radon
Corrosion of pipes, plumbing	Corrosion, pH, lead
Nearby areas of intensive agriculture	Nitrate, nitrite, pesticides, coliform bacteria
Coal or other mining operations nearby	Metals, pH, corrosion
Gas drilling operations nearby	Chloride, sodium, barium, strontium
Dump, junkyard, landfill, factory, gas station or dry-cleaning operation nearby	Volatile organic compounds, total dissolved solids, pH, sulfate, chloride, metals
Odor of gasoline or fuel oil, and near gas station or buried fuel tanks	Volatile organic compounds
Objectionable taste or smell	Hydrogen sulfide, corrosion, metals
Stained plumbing fixtures, laundry	Iron, copper, manganese
Salty taste and seawater, or a heavily salted roadway nearby	Chloride, total dissolved solids, sodium
Scaly residues, soaps don't lather	Hardness
Rapid wear of water treatment equipment	pH, corrosion
Water softener needed to treat hardness	Manganese, iron
Water appears cloudy, frothy or colored	Color, detergents



## **Well Water Quality Cost Share Program**

To incentivize well water testing, the Taos Soil and Water Conservation District (TSWCD) is offering a **50/50** cost-share opportunity, with a maximum District contribution of up to **\$500** per household. This program is available to **Taos County residents located outside the Town of Taos** and is intended solely for residential (non-commercial) use. Water quality tests are to be performed by laboratories certified by NMED-DWB to analyze drinking water samples for water systems in New Mexico. TSWCD will not reimburse tests performed at non-certified laboratories. As part of the program, participants are required to share their water test results with the District. However, all shared data will remain anonymous—results will not be linked to applicant names or addresses. The purpose of collecting this information is to support regional water resource managers and contribute to broader water quality databases, helping to build a clearer picture of groundwater conditions across Taos County. This program is offered on a first come first serve basis and first-time participants will be prioritized.

### **Required Forms for the Well Water Quality Cost Share Program:**

1. Well Water Quality Cost Share Application form.
2. A copy of a recent property tax bill showing proof of property ownership OR if renting or leasing, written permission, property tax bill and contact information of property owner.
3. Official Test Results from laboratories.

*To qualify, applications must be approved **before testing begins**. This program is for **Taos County residents, not including residents located within the Town of Taos**. If approved, TSWCD will allocate a budget of up to **\$500 per household**, dependent on individual testing needs and available funding. This program has limited funding and is offered on a first come first serve basis. A site visit and well mapping will be completed prior to testing. Approved landowners may be reimbursed for up to **50% of testing costs**, not to exceed their approved budget. Please note that Taos SWCD is not responsible for test results or result interpretations. Participation in this program is voluntary.*

### **Important Laboratory Sample Guidelines:**

- Each laboratory has its own specific instructions for collecting and delivering samples.
- It is your responsibility to contact the laboratory directly to confirm and follow their requirements.
- Most laboratories require samples to be delivered Monday–Thursday. Deliveries on Friday may result in extra weekend fees. If you are shipping your sample, you must follow shipping instructions provided by the laboratory.
- Failed samples that are not collected according to laboratory standards or not mailed properly will not be reimbursed by TSWCD.

If you are unable to deliver your sample yourself, coordinated group drop-offs can be arranged.

**Please note:** if using our drop off services, laboratories will be chosen by TSWCD based on cost and location.
